Call information

In the framework of the first Call for proposals of the 2014-2020 period, the Programme has so far approved 6 projects for funding. Details on these projects can be found on the [Programme website](#).

Whether new projects will be approved soon, will depend on the decisions of the next Monitoring Committee on 12 and 13 July. Currently, 14 projects resubmitted from Call 1 and 14 new application forms submitted under Call 2 are under assessment, so chances are rather high that new cross-border partnerships will receive green light to launch their project.

Partnerships that are looking forward to submitting a fresh Concept Note are encouraged to stay updated via the Programme website. Once the Monitoring Committee has decided on a detailed timing, the information will be made available through the website.



State aid update



The 2 Seas website now contains a section fully dedicated to state aid. This section aims at supporting applicants during their application phase when questions on state aid could arise. Specific documents can be found such as a detailed guidance for applicants, SME qualification test etc.

MIRG-EU

The succes of the Maritime Incident Response Groups project, partially financed by INTERREG IVA 2 Seas, has caught the attention of the European Commission. After the completion of the MIRG-EU activities in 2014, the partnership received new funding from the Directorate-General for Humanitarian Aid and Civil Protection (ECHO) in order to continue their cooperation.

During the MIRG-EU project, the partners gained knowledge and skills that are of value to other regions that deal with maritime safety issues. The project wishes to make its MIRGs available through the EU Civil Protection mechanism. In order to learn whether the teams are ready for this assignment, a full scale exercise will be organised on 11 and 12 October 2016.
